  - 2.2. Registration Certificate;
    - 2.2.1 DTI (sole proprietorship); or
    - 2.2.2 SEC (partnership/corporation); or
    - 2.2.3 CDA (cooperatives);
  - 2.3. Mayor's or Business Permit;
  - 2.4. Tax Clearance;
  - 2.5. Bid Security, in the following forms and formats:
    - 2.5.1. Bid Securing Declaration; or
    - 2.5.2. The amount of not less than **PhP8,280.60** (2% of the ABC) if the bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit; or
    - 2.5.3. The amount of not less than **PhP20,701.50** (5% of the ABC) if the bid security is in Surety Bond;
  - 2.6. Duly-accomplished conformity with the Technical Specifications, shall be attached to the quotation<sup>2</sup>. Please refer to the attached checklist of eligibility requirements to ensure a complete and correct submission of requisite documents.
3. The prospective bidders may submit an offer that provides for superior quality and/or better terms and conditions at no extra cost to the OP-PMS.
4. All quotations shall be considered as fixed prices and are, therefore, not subject to price escalation during contract implementation.
