

CONTRACT OF AGREEMENT

STONE MASONRY SLOPE PROTECTION FOR RSU ADMIN BUILDING (BOARD ROOM SIDE) (ABC: PHP5,000,000.00, QTY: 1 LOT)

THIS AGREEMENT, made this 14th day of December 2022 between:

The **ROMBLON STATE UNIVERSITY**, a public Higher Education Institution, created and existing under Republic Act (R.A) No. 9721, with principal office at Brgy. Liwanag, Odiongan Romblon, duly represented herein by its **President, MERIAN P. CATAJAY-MANI, Ed.D, CESE**, (hereinafter called the "**PROCURING ENTITY**");

-and-

TWIN DRAGON CONSTRUCTION SUPPLIES, a private business entity duly organized and existing under and by virtue of the laws of the Philippines, with business address at Tabing Dagat, Odiongan, Romblon, duly represented by its **General Manager, MR. ALYKHAN F. FERNANDEZ** (hereinafter called the "**CONTRACTOR**").

WHEREAS, the **PROCURING ENTITY** is desirous that the **CONTRACTOR** execute the **STONE MASONRY SLOPE PROTECTION FOR RSU ADMIN BUILDING (BOARD ROOM SIDE) (ABC: PHP5,000,000.00, QTY: 1 LOT)** (hereinafter called "the Works") and the Entity has accepted the Bid of **FOUR MILLION, ONE HUNDRED FORTY-FOUR THOUSAND, FOUR HUNDRED FORTY-NINE PESOS AND EIGHTY-FOUR CENTAVOES ONLY (PHP4,144,449.84)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g.,

Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **FOUR MILLION, ONE HUNDRED FORTY-FOUR THOUSAND, FOUR HUNDRED FORTY-NINE PESOS AND EIGHTHY-FOUR CENTAVEOS ONLY (PHP4,144,449.84)** or such other sums as may be ascertained, **TWIN DRAGON CONSTRUCTION** agrees to execute and complete the Works and remedy any defects therein in accordance with his/her/its Bid.
 4. The **ROMBLON STATE UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
