

CONTRACT OF AGREEMENT

PROCUREMENT OF CONSULTING SERVICES FOR THE IMPLEMENTATION OF SMART CAMPUS PROJECT (ABC: PHP1,500,000.00, QTY: 1)

THIS AGREEMENT, made this ____ day of June 2023 by and between:

ROMBLON STATE UNIVERSITY, a public Higher Education Institution, created and existing under Republic Act (R.A) No. 9721, with principal office at Brgy. Liwanag, Odiongan Romblon, duly represented herein by its **President, MERIAN P. CATAJAY-MANI, Ed.D, CESE**, and herein after referred to as the "**PROCURING ENTITY**;"

-and-

ACC TECHNOLOGY CONSULTING INC., a private business entity duly organized and existing under and by virtue of the laws of the Philippines, with business address at Level 10-01, 31st Street Corner 3rd Avenue, Bonifacio Global City, Taguig City, duly represented by its **Authorized Representative, MR. AMBROCIO B. CRISOSTOMO**, hereinafter referred to as the "**CONSULTANT**."

WHEREAS, the **PROCURING ENTITY** is desirous that the **CONSULTANT** execute **Consulting Services for the Implementation of SMART Campus Project (ABC: PhP1,500,000.00, QTY: 1)** (hereinafter called "the Works") and the **PROCURING ENTITY** has accepted the bid of **One Million, Four Hundred Eighty-Eight Thousand, Eight Hundred Eighty-Eight Pesos and Eighty-Eight Centavos (PhP1,488,888.88)** by the **CONSULTANT** for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Terms of Reference
 - (c) Request for Expression of Interest;
 - (d) Instructions to Bidders;
 - (e) Bid Data Sheet;
 - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/ statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (h) Eligibility requirements, documents and/or statements;

- (i) Performance Security;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the **PROCURING ENTITY** to the **CONSULTANT** as hereinafter mentioned, the **CONSULTANT** hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The **PROCURING ENTITY** hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
