## RSU – BOR RESOLUTION NO. 85, S. 2023

### RESOLUTION APPROVING THE ROMBLON STATE UNIVERSITY ANNUAL PROCUREMENT PLAN FOR FY 2024 (FUND 101, FUND 164, FUND 163)

**WHEREAS**, the 2024 Annual Procurement Plan is a consolidation of all the Project Procurement Management Plans (PPMPs) submitted by every delivering unit of the University to the Bids and Awards Committee (BAC);

**WHEREAS**, the Bid and Awards Committee, through Resolution No. 23-129, recommended the approval of the APP for Fund 101 with a total budgetary requirement of Sixty-Three Million, Nine Hundred Eighty-One Thousand Pesos (₱63,981,000.00);

**WHEREAS**, the Bid and Awards Committee, through Resolution No. 23-130, recommended the approval of the APP for Fund 164 with a total budgetary requirement of One Hundred Sixty-Five Million, Two Hundred Forty-Six Thousand, One Hundred Ninety-One Pesos and Thirty-Six Centavos (₱165,246,191.36);

**WHEREAS**, the Bid and Awards Committee, through Resolution No. 23-131, recommended the approval of the APP for Fund 163 with a total budgetary requirement of Five Million, Five Hundred Six Thousand, Six Hundred Forty-One Pesos and Ten Centavos (₱5,506,641.10);

**WHEREAS**, the Administrative Council of the University endorsed the APP to the Finance Committee;


**WHEREAS**, the Finance Committee reviewed the APP of the University and endorsed it to the Board for approval;

**BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, that upon its discussion and agreement, the Board **APPROVED** the Romblon State University Annual Procurement Plan for FY 2024 (Fund 101, Fund 164, Fund 163).
