BAC RESOLUTION NO. 24-76

DECLARING THE BID OF LANCASTER TECHNOLOGY AND DEVELOPMENT CORPORATION WITH THE BID AMOUNT OF ONE BILLION, FIVE HUNDRED NINETY-EIGHT MILLION, EIGHT HUNDRED TEN THOUSAND, THREE HUNDRED PESOS (PHP 1,598,810,300.00) AS THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) FOR THE PROCUREMENT OF THE "DIGITAL RESILIENCY DEVELOPMENT PROGRAM"

WHEREAS, under Resolution No. 02, S. 2024, dated 23 January 2024, the Romblon State University (RSU)-Board of Regents (BOR) approved the Revised Annual Procurement Plan (APP) for Fiscal Year (FY) 2024;

WHEREAS, pursuant to Resolution No. 04, S. 2024, dated 23 January 2024, the RSU-BOR approved the authority to the University President to implement Locally-Funded Projects in the General Appropriations Act for FY 2024 which includes the Digital Resiliency Development Program (PhP1,600,000,000.000);

WHEREAS, the Bids and Awards Committee (BAC) received Purchase Request No. 24-03-050 for the "Digital Resiliency Development Program" indicating therein the technical specifications and other terms and conditions of the program with an Approved Budget for the Contract (ABC) amounting to One Billion, Six Hundred Million Pesos (PhP1,600,000,000.00);

WHEREAS, the BAC advertised the Invitation to Bid (ITB) for the said procurement project on the Philippine Government Electronic Procurement System-PhilGEPS (notices.philgeps.gov.ph), at the RSU website (www.rsu.edu.ph), and at conspicuous places from 22 March 2024 to 01 April 2024;

WHEREAS, only Lancaster Technology and Development Corporation submitted bidding documents on or before the deadline set on 15 April 2024, 10:00 AM;

WHEREAS, after preliminary examination of the Legal, Technical and Financial Documents, and Technical Requirements of the bidder during the Opening of Bids on 15 April 2024, 10:00 AM using a non-discretionary "pass/fail" criterion, the BAC Chairperson announced the result of the said evaluation, as follows:
